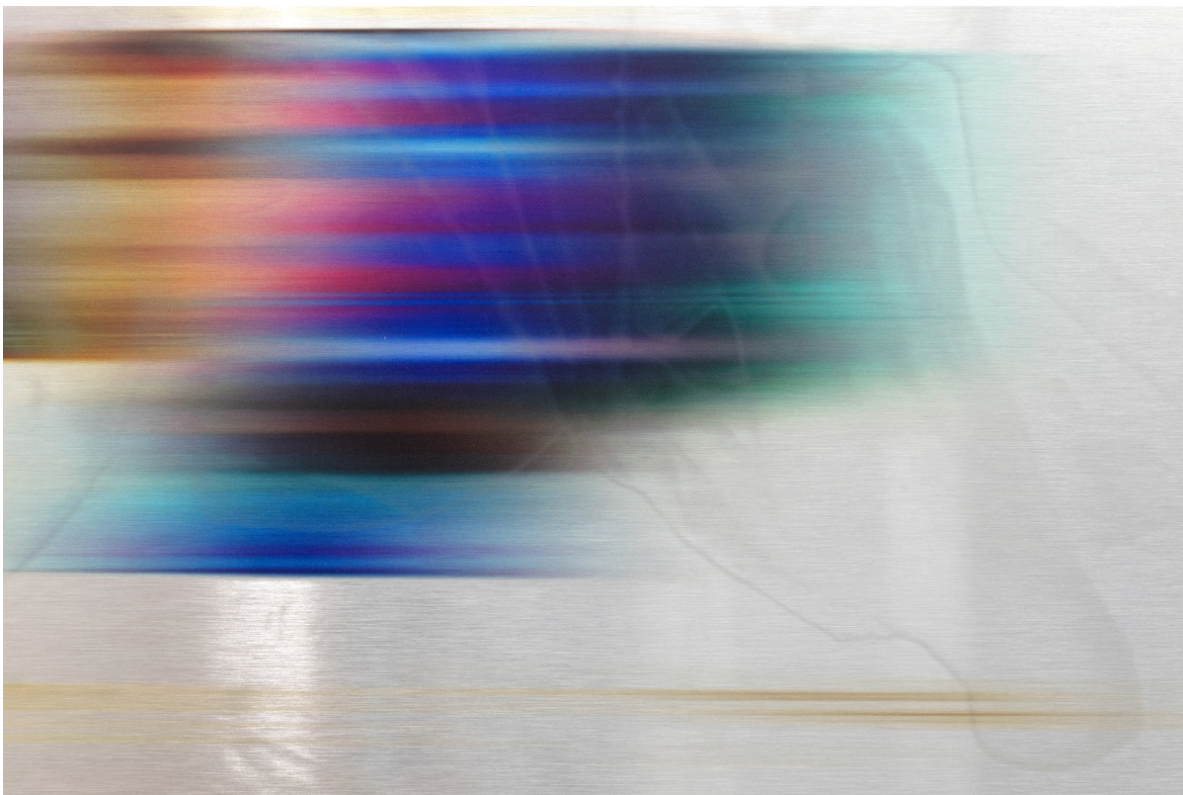

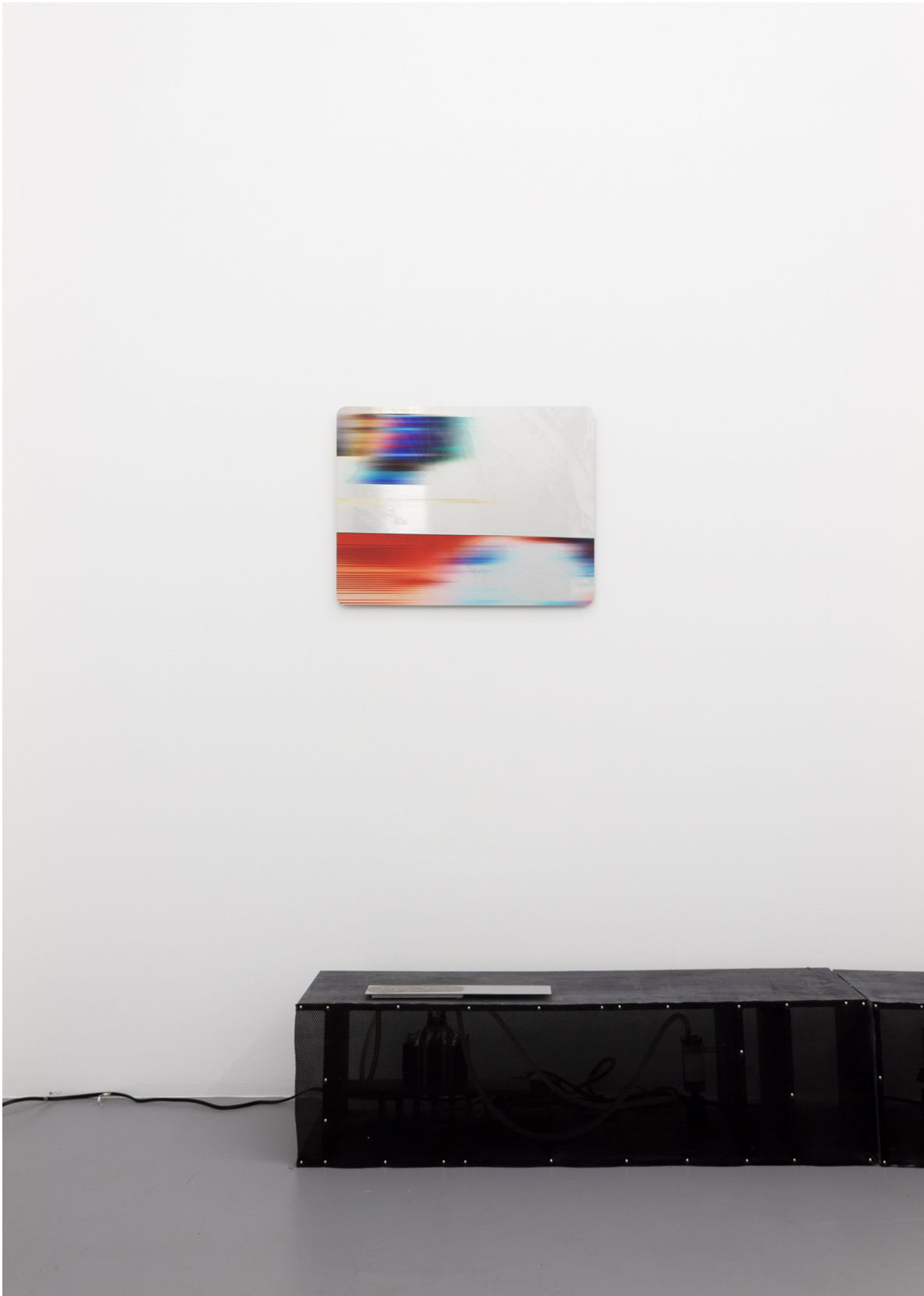

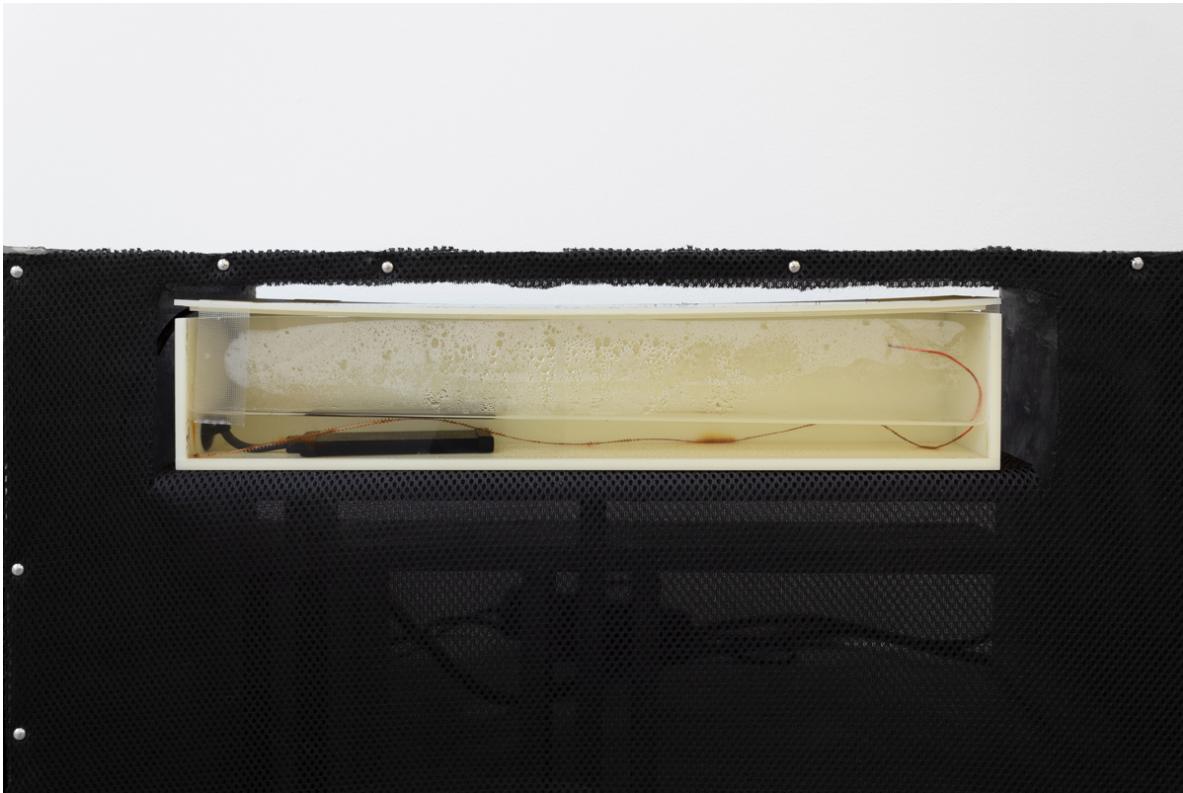

A clear PVC curtain is installed over the doorway connecting the gallery and office at Prairie. This object is not an artwork.

The artist provided Prairie staff with customized uniforms that they are required to wear during open hours. These clothes belong to them. They are also tasked with maintaining the artworks in the exhibition and caring for all visitors to the gallery.

"CJ" Craig Jun Li (b. 1998, China) is an artist based in Brooklyn, New York. Driven by research interests in circulation and semiotics, Li's work often configures as inconstant installations utilizing perishable materials and architectural elements. Their practice aims to investigate the oscillation between a given subject and how it's perceived.
