


1. Consignor agrees to consign the Work to Consignee until January 21, 2014. In the event of any sale of the Work, a thirty percent (30%) discount will be given to Consignee, and Consignee shall furnish Consignor with the name and address, and accompanying invoice details of the purchaser of the work. Consignee agrees not to invoice the collector directly; any and all invoicing shall be done by the Consignor. Any discount should be discussed with 303 Gallery prior to finalizing the sale. Consignor shall not be held to this consigned price after the consignment date expires above. Any extension of the consignment period and any sale of the Work after the initial consignment period shall require the prior written consent of Consignor, especially with respect to the pricing of the Work. Work must remain in the possession of Consignee unless Consignor gives prior written permission or until Consignor is paid in full. Consignee agrees not to sell the Work to another gallery, at auction or at an art fair without the written consent of the Consignor. In the case of placing the work with a collector through a consultant, the collector must be invoiced directly.
2. Consignee shall be responsible for packing, shipping, and insurance of the Work from the Consignor to the Consignee, and from the Consignee to the address specified by Consignor at the end of the consignment period: 303 Gallery, 507 W 24th Street, New York, NY 10011 USA. Insurance shall be nail to nail, for an amount no less than the full price of the Work as listed above, and shall designate Consignor as the beneficiary. Consignee shall arrange for professional packing of the Work, and shall return the Work in good condition.
3. Consignee shall be responsible for any and all costs incurred in connection with the handling, transportation, duties, taxes, and condition checking of the Work both prior to its release by Consignor and upon acceptance of the Work by Consignee or Consignee's representative.
4. Consignee shall provide the Consignor and the artist of the Work each with digital images of the Work and of overall installation views. In return, Consignor shall be happy to provide or loan any biographical or photographic material where available.
5. Neither Consignor nor the artist of the Work shall be responsible or liable for any damage to the Work or any damage caused by the Work. This agreement shall be governed by the laws of the state of New York.
6. In the case that the Consignee is located outside of the United States the Consignee shall not sell to any collectors, dealers or institutions in the United States or the sale is void and will not be honored by either the artist or 303 Gallery, title will not pass.
7. All image reproductions should be reproduced with the credit "Courtesy 303 Gallery, New York."
8. 303 Gallery is the Agent of the Artist.
9. Price subject to change.
10. It is agreed that a faxed or scanned signature, in this case, is legally binding. If the Consignee breaches any terms or conditions, title of this artwork does not pass. In the event of a sale, the Consignor shall be notified in writing and provided with the name and address of the buyer. Any amendments to the above terms of this agreement must be in writing.
